SECTION 2 HAZARD IDENTIFICATION

EMERGENCY OVERVIEW:

WARNING: Gases Under Pressure, Irritant



POTENTIAL HEALTH EFFECTS: Eyes: May cause irritation. Organisms used are nonpathogenic but can cause infection when in contact with open wounds. These organisms are susceptible to many commonly used antibiotics.

Skin: Slight redness on hands and forearms, if individual has a history of dermal allergic reaction. Dermatitis and skin sensitization can develop after repeated and/or prolonged contact.

SECTION 4 FIRST AID MEASURES

First Aid Procedures:

Eye contact: Hold eyelids apart and immediately flush eyes with plenty of water for at least 15 minutes. After initial flushing, remove any contact lenses and continue flushing for at least 15 minutes. Call a physician if irritation persists.

Skin contact: For skin contact flush with large amounts of water. Call a physician if irritation persists.

Inhalation: Immediately remove from further exposure. Give supplemental oxygen, if breathing is difficult. If breathing has stopped, assist ventilation with a mechanical device or use mouth-to-mouth resuscitation.

Ingestion: IF SWALLOWED: Immediately call a POISON CENTER or doctor/physician. If swallowed, do NOT induce vomiting. Give a glass of water. Never give anything by mouth to an unconscious person.

Note to physician: If the product is ingested, treat the affected person symptomatically.

SECTION 5 FIRE FIGHTING MEASURES

EXTINGUISHING MEDIA: Water fog. Foam. Dry chemical powder. Carbon dioxide (CO₂). Appropriate for surrounding fire.

UNUSUAL FIRE & EXPLOSION HAZARDS: Contents under pressure. Do not expose to temperatures exceeding 120°F as containers may vent, rupture, or burst.

SECTION 6 ACCIDENTAL RELEASE MEASURES

Personal precautions: Isolate area. Keep unnecessary personnel away. Stay upwind. Keep out of low areas. Ventilate spaces before entering.

Environmental precautions: Prevent further leakage or spillage if safe to do so.

Methods for containment: Prevent entry into waterways, sewers, basements or confined areas.

Methods for cleaning up: Eliminate ignition sources including sources of electrical, static or frictional sparks. Wear appropriate protective equipment and clothing during clean-up.

Small Spills: Use a non-combustible material like vermiculite, sand or earth to soak up the product and place into a container for disposal.

Large Spills: Dike far ahead of liquid spill for later disposal. Do not discharge effluent containing this product into lakes, streams, ponds, estuaries, oceans or other waters unless in accordance with the requirements of a National Pollutant Discharge Elimination System (NPDES) permit and the permitting authority has been notified in writing prior to discharge. Do not discharge effluent containing this product to sewer systems without previously notifying the local sewage treatment plant authority. Handling: Keep away from heat, sparks, and open flames. Avoid breathing mist. Avoid contact with skin and eyes. Wear suitable protective clothing. Wash hands after handling.
